

Limited Warranty

All Weather Floors, LLC warrants your containment mat to be free from defects in material and workmanship for a period of 1 year from the date of purchase. The warranty shall be subject to the following conditions, terms and exclusions:

The exclusive remedy under the warranty shall be the repair, replacement or refund of purchase price by All Weather Floors, LLC at All Weather Floors, LLC's option. The warranty is for manufacturer's defects and does not cover wear and tear, abuse, misuse or damage caused by onsite or environmental conditions, acts of nature, chemicals, solvents or discoloration. The product is not intended for use with snow chains or studded tires and is not intended to be used as garage flooring. The product may be slick when wet.

In the event of a tear, puncture, burn or tire mark, All Weather Floors, LLC shall make the following options available to the customer. Within 90 days of purchase the customer may return the damaged mat at the customer's expense and receive a replacement at 50% off of the current retail price posted on the All Weather Floors, LLC website. Within 180 days of purchase the customer may return the damaged mat at the customer's expense and receive a replacement at 30% off of the current retail price posted on the All Weather Floors, LLC website. Within 1 year of purchase the customer may return the damaged mat at the customer's expense and receive a replacement at 25% off of the current retail price posted on the All Weather Floors, LLC website.

All Weather Floors, LLC specifically disclaims all other warranties including but not limited to warranty of fitness of a particular purpose and warranty of merchantability.

This product is only intended for use in a fully enclosed garage with a concrete floor.
